From Show Site:

Approx. Time & Distance: 16 minutes (8.7 miles)

Proceed West on Manitowoc Road. Turn right on Oneida Street/US Hwy 10 (1 mile). Turn left on US Hwy 10 West to Oshkosh (1.1 miles). Enter ramp following the sign US Hwy 10 to Oshkosh (50 ft). Exit Right following the sign Green Bay/I-41 North (3.8 miles). Exit Right following the sign CR BB/Prospect Avenue (Exit #136) (1.7 miles). Ramp forks, keep Left to CR-BB West (0.2 miles). Exit ramp (Left) at W. Prospect Avenue/CR-BB (100ft.) Turn Right on S. Casaloma Drive (0.6 miles). Turn Left on New Horizons Blvd (1000 ft.). Arrive at Fox Valley Animal Referral Center (300 ft)

“Dogs found in an unsafe environment, distress or harm’s way (for example: left unattended on a grooming table in a noose not attached to a safety release clip; left in a vehicle without proper ventilation) will be removed to safety. Exposing a dog to an unsafe environment, distress or harm’s way is considered mistreatment.”

Exhibitors should follow their veterinarian’s recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

From South: I-43 North to West Hwy 10, go left. Follow Hwy 10 approx. 30 miles to Menasha. At stoplights (Oneida St), turn right. At the next set of stop lights (Manitowoc Rd.) turn right. Dog Club is 1/2 mile down this road on the right side.

From South (alternate route): I-41 North to Exit 134 (Hwy 441 & 10), merge right over large bridge. Exit Oneida St., turn right. Go south to stop lights at Manitowoc Rd, turn left. Dog Club is 1/2 mile down this road on the right side.

From West: Hwy 10 East. Exit Oneida St., turn right. Go south to stop lights at Manitowoc Rd, turn left. Dog Club is 1/2 mile down this road on the right side.

From North or East: I-41 to Exit 145 (Hwy 441). Exit Oneida St, turn left. Go south to stop lights at Manitowoc Rd, turn left. Dog Club is 1/2 mile down this road on the right side.
